

FENCE REQUIREMENTS

All fences must meet the requirements as set forth in our
City Ordinance

What you need at time of permit application:

1. A letter of approval from your Home Owners Association, if one exists.
2. A drawing of your lot showing distances from all lot lines and structures to your new fence. A detailed drawing showing all dimensions, construction material, footers, type and size of fence. Remember if you have a corner lot you are dealing with to front yard requirements.
3. All drawings may be completed by the home owner or a design professional.
4. All contractors must be registered with the city. (See contractors registration code 1361.01)
5. Please allow 5 business days for your plans to be reviewed. Larger projects may require extended review time. We will call you with your permit fees once approval is given.
6. No work may begin prior to plan approval.

Inspection required : Upon completion of the installation a final build inspection is required. It is your responsibility to call and schedule any inspections with the Building Department
